ENHANCED SAFETY PRACTICES

(Updated 8/14/2020)

- ✓ We have up-graded our HVAC system to constantly sanitize the air we breathe in the office. This technology uses ionized hydro-peroxides and UV light to sanitize the air. Hydro-peroxides have been shown to safely remove the risks of bacteria, viruses and mold spores.
- ✓ We have installed air purifiers with HEPA filters and UVC sanitizers in each treatment room.
- ✓ We have implemented powerful chair-side vacuums designed to significantly reduce the amount of aerosols/contaminants that are entering the air while we are performing dental treatment.
- ✓ ALL team members are wearing appropriate Personal Protective Equipment (PPE).
- ✓ ALL team members are being screened before the start of each day. If anyone presents with any COVID-19 symptoms, they will be asked to leave and not return to work until after applicable COVID-19 testing and being symptom-free for two weeks.
- ✓ Phone screening of all patients prior to their appointments:
 - We are asking questions to evaluate for any signs of illness or contact with COVID-19 prior to appointments. If illness or contact is encountered, the patient's appointment will be rescheduled.
 - All patients will be symptom-free for at least 2 weeks prior to us treating them.
 - We are asking that all patients take their temperature before leaving their house to ensure they do not come into the office if their temperature is 100.4°F or greater.
 - Once patients are in the office, we use a contact-free thermometer to verify their temperature.
- \checkmark We are limiting the number of patients in our waiting room to 3 to maximize social distancing.
 - If you would prefer to wait outside of the office or in your car, you can call us once you are here and we will let you know when you can come into the office.
 - Only patients with appointments will be allowed to enter the office.
- ✓ EVERY person MUST wear a face mask while in our office.
- ✓ Upon entering the office, EVERY person MUST first wash their hands with soap and water for 20 seconds prior to signing in.
- ✓ Any pen or clip board that is used to sign paperwork has been disinfected.
- ✓ We have installed plexi-glass protective barriers at each of our reception locations.
- ✓ Hand sanitizer is available.
- ✓ We will continue to adhere to our strict disinfection protocols of all of our instruments and treatment rooms, and in addition, sanitize any frequently touched surfaces (ie. door knobs, countertops) with a medical-grade surface disinfectant (CaviCide).
